**About the Program:** Ron Kernan and Josh Richards with KPFF will share their experiences with ASCE-31 and ATC-20 evaluations in Haiti from February 15th through 27th. They were able to see three cities on the north side of the island, Cap-Haitian, Ft. Liberte, and Milot which were essentially undamaged as well as Port au Prince and Leogane, near the epicenter, which both sustained significant damage.

#### **Wind and Seismic Committees**

ASCE 7 will be publishing a new edition in 2010, which will be adopted in the 2012 IBC. We understand ASCE 7-10 will make major changes in the approach to seismic and wind load derivation. SEAO wishes to task our Seismic and Wind committees with reviewing the ASCE 7-10 document to evaluate the respective wind and seismic section revisions

and new approaches. The committees will then make recommendations for state specific changes to the Oregon Building Codes Division on behalf of SEAO for the revised OSSC which will accompany the adoption of the 2012 IBC by the State of Oregon.

After many years of faithful service, Dominic Webber is stepping down from the chairmanship of the Seismic committee. We greatly appreciate Dominic's past contributions to the committee. Chad Kilian has already volunteered to join the Seismic committee. Welcome Chad! Jim Riemenschneider is the current chairman of the Wind Committee. I would like to recruit another 4 or 5 members of varying experience levels to serve on each of these committees and undertake this task.

#### **Newsletter**

Another committee that we want to inject new life into is our Newsletter Committee. I'm sure there are members out there with latent or budding literary talents.
